Hearing Date: September 13, 2006

Subject Matter of Proposed Regulation: Fees

Section Affected: California Code of Regulations, Title 16, Division 26, Section 2649

UPDATED INFORMATION

The Initial Statement of Reasons is included in the file. The information contained therein is updated as follows:

The California Architects Board issued a 15-day Notice of Modified Language on June 19, 2007 to change the effective date of the regulation to October 3, 2007.

LOCAL MANDATE

A mandate is not imposed on local agencies or school districts.

SMALL BUSINESS IMPACT

This regulation will not have a significant adverse economic impact on small businesses.

CONSIDERATION OF ALTERNATIVES

No reasonable alternative which was considered or that has otherwise been identified and brought to the attention of the California Architects Board or Landscape Architects Technical Committee would be either more effective in carrying out the purpose for which the action is proposed or would be as effective and less burdensome to affected private persons than the proposed regulation.

OBJECTIONS OR RECOMMENDATIONS/RESPONSES

There were no objections or recommendations regarding the proposed action during either the 45-day comment period nor the 15-day notice period for modified text.
